Conditions of Use

- 1) All requests to reproduce holdings of the Rock and Roll Hall of Fame and Museum Library and Archives (the "Library & Archives"), which may include photographs, film, video, manuscripts, maps, and other documents, must be submitted on this application. By signing this application, the applicant agrees to abide by all terms, conditions, and provisions of this document and of all applicable law.

Permission for reproduction is granted only when the requirements of this document are met and this application is signed by an authorized representative of the Library & Archives. Permission for reproduction is limited to the applicant and is non-transferable.

Permission for reproduction is granted only for the expressed purpose described in this application (the "Authorized Product"). This permission is non-exclusive, and the Library & Archives reserves the right to reproduce the image or document and allow others permission to reproduce the image or document.

Any subsequent use (including subsequent editions, paperback editions, foreign language editions, etc.) constitutes reuse and must be applied for in writing to the Library & Archives. Any change in use from that stated on the application (e.g., increased size of edition, change in market) requires permission from the Library & Archives. In the event that the applicant engages in unauthorized reproduction, the applicant agrees to pay the repository a sum equal to three times the normal fee (see the **Reproduction Fee Schedule**), not as a penalty but as liquidated damages agreed upon due to the difficulty in assessing actual damages incurred. The Library & Archives may in the event of unauthorized reproduction require surrender of all materials containing such unauthorized reproductions, and the applicant agrees that such materials shall be immediately surrendered upon receipt of a request from the Library & Archives. The liquidated damages operate separately from any indemnity obligations of Applicant, and do not prevent recovery by the Library & Archives for actual damages arising from claims by third parties, nor do they prevent the Library & Archives from seeking an injunction or other equitable relief for intellectual property violations by applicant.

The Library & Archives reserves the right to refuse reproduction of its holdings if it feels that fulfillment of that request may violate copyright or other laws. The Library & Archives reserves the right to refuse reproduction of its holdings and to impose such conditions as it may deem advisable in its sole and absolute discretion in the best interests of the Library & Archives.

- 2) Beyond the permission of the Library & Archives, additional permissions for reproduction or use may be required. Those permissions may include, but are not limited to:

Copyright: In cases of living artists and/or materials subject to the 1976 Copyright Law or the 1991 Visual Artists Rights Act, written permission must be secured by the applicant from the artist, his/her agent, or the copyright owner and provided to the Library & Archives before a reproduction will be released.

Warning Concerning Copyright Restrictions

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material. Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction. One of these specified conditions is that the photocopy or reproduction is not to be "used for any purpose other than private study, scholarship, or research." If a user makes a request for, or later uses, a photocopy or reproduction for purposes in excess of "fair use," that user may be liable for copyright infringement. This institution reserves the right to refuse to accept a copying order if, in its judgment, fulfillment of the order would involve violation of copyright law.

Privacy: An individual depicted in a reproduction has privacy rights as outlined in Title 45 Code of Federal Regulations 46 (Protection of Human Subjects). The Library & Archives reserves the right to require a release from individuals whose privacy may be violated by the reproduction of an image.

Owner of original: In instances where the Library & Archives holds only a reproduction, the written permission of the owner of the original is required.

It is the responsibility of the applicant to obtain **Permission to Publish** from the owner of copyright (the institution, the creator of the record, the author, or his/her transferees, heirs, legatees, or literary executors). The Library & Archives will aid the applicant in contacting such individuals as available; however, the Library & Archives does not warrant the accuracy of the contact information and shall not be responsible for any inaccurate information.

In instances where the owner of copyright cannot be contacted, the Library & Archives may consider granting permission for reproduction based on the applicant's evidence of a good faith effort to contact the appropriate individual or institution. However, the Library & Archives assumes no responsibility for infraction of copyright laws, invasion of privacy, or any other improper or illegal use that may arise from reproduction of an image.

IN ALL INSTANCES, THE APPLICANT AGREES TO HOLD THE LIBRARY & ARCHIVES AND ITS AGENTS AND RELATED PARTIES HARMLESS FROM AND AGAINST ANY AND ALL CLAIMS OR CAUSES OF ACTION ARISING OR RESULTING FROM THE USE OF THE MATERIAL, INCLUDING VIOLATIONS OF INTELLECTUAL PROPERTY RIGHTS, AND SHALL INDEMNIFY THE LIBRARY & ARCHIVES AND ITS AGENTS AND RELATED PARTIES FOR ANY AND ALL COSTS AND DAMAGES (INCLUDING, WITHOUT LIMITATION, ATTORNEYS' FEES AND COURT COSTS) ARISING OR RESULTING FROM SUCH USE.

- 3) All reproductions must include the name of the Rock and Roll Hall of Fame and Museum Library & Archives in a caption or credit. The Library & Archives may also require that the artist/creator, the title of the work, the title of the collection, and, in some cases, the credit line required by the donor appear in the caption or credit.

Credits should appear in close proximity to the image or in a special section devoted to credits. However, reproductions distributed electronically must contain the credit or caption as part of the image, displayed in letters which are at least 3/8" high in a legible typeface. When permission is granted to disseminate reproductions electronically, the Library & Archives reserves the right to require an electronic watermark or other identifying code within the scanned file.

The payment of a commercial use fee does not exempt the user from the credit line requirement. Failure to include a credit line or electronic watermark, or inaccurate captions or credits, shall require the applicant to pay the sum of one hundred dollars (\$100) per image, as liquidated damages and not as a penalty, in view of the difficulty in assessing actual damages for this breach.

- 4) Reproductions supplied by the Library & Archives may not be copied, scanned, exhibited, resold, or used for any other purpose than that specified in this application. Copies shall not be deposited in another library, archives, or repository.
- 5) Unless approved in advance by the Library & Archives, each item must be reproduced unaltered in its entirety; the image cannot be cropped, overprinted, printed on color stock, or bleed off the page.

The Library & Archives reserves the right to examine proofs and captions for accuracy and sensitivity before publication with the right to revise if necessary. The Library & Archives reserves the right to refuse any request and to impose such conditions as it may deem advisable in the best interests of the Library & Archives.

If permission is granted to distribute an electronic copy of an image, the distributed copy shall not exceed a resolution of 300 DPI. Scanned files must be destroyed once the final Authorized Product has been produced.

The applicant covenants, represents, and warrants that the Authorized Product will not contain any feature which would permit users to distort or mutilate the image, nor will the Authorized Product be knowingly designed or prepared so as to be compatible with any computer program that is designed to manipulate graphic images, audio, or video content.

- 6) The permission granted hereunder does not include the right to include an image in any printed or electronic materials accompanying the Authorized Product, or in any advertisement for the Authorized Product other than is expressly permitted below:

Solely in connection with the marketing and distribution of the Authorized Product, applicant may use an image on the packaging of the Authorized Product and in any advertisement, product catalogs, or publicity or promotional materials (a "Promotional Use"), provided that the Library & Archives, The Rock and Roll Hall of Fame and Museum, Inc. ("Rock Hall") shall be given a credit on the same page as the image appears. Applicant agrees that any Promotional Use will be made solely in a manner that indicates the item is part of the content of the Authorized Product, and the Rock Hall's name will not be used as an aesthetic or design element in such Promotional Use. Without limiting the generality of the foregoing, applicant shall not use the image or the Rock Hall's name in any manner that creates any association between the image and/or the Rock Hall, on one hand, and applicant, on the other hand, to such an extent that any goodwill towards the Authorized Product or applicant arises from the image and/or the Rock Hall's name, and applicant agrees that it does not have any right to claim and will not claim, under any circumstances whatsoever, that such goodwill has arisen or that the applicant is entitled to the benefits, if any, of such goodwill.

- 7) Prepayment of all fees is required before permission is granted. If the size of edition or number of editions exceeds the terms specified in this application, the applicant shall immediately notify the Library & Archives and pay the difference in fees. If payment is not received within thirty (30) days of such notice from the applicant or from the date of notice from the Library & Archives, the applicant agrees to pay a fee equal to twice the originally quoted fee.
- 8) The applicant agrees to send the Library & Archives one copy, best edition, of the Authorized Product containing the reproduction at no charge. All expenses for shipping and handling are to be borne by the applicant.

9) *Contract Claims and Controversies*: This Permission to Publish: (i) is governed by and should be construed in accordance with the laws of the State of Ohio, applicable to contracts entered into and fully performed in that State, (ii) is the entire agreement between the parties and supersedes all other agreements (oral or written) concerning its subject matter; (iii) may be modified only by a writing signed by all parties; (iv) is binding on the parties' successors and heirs; and (v) may be signed in counterparts, each of which is an original and all of which together constitute the same instrument. The parties irrevocably agree to submit any dispute arising from or related to this Permission to Publish to the exclusive jurisdiction of any applicable state or federal courts located in the County of Cuyahoga in the State of Ohio and will make no attempt to transfer venue for any reason, including inconvenience.

10) *Credit Line Must Read*: Library & Archives, The Rock and Roll Hall of Fame and Museum.

11) Reproduction is permitted only from prints or digital copies supplied by the Library & Archives.

12) The permission granted terminates immediately upon publication.
